
Bringing the Culturally and Linguistically Appropriate Services (CLAS) Standards to Life

Bringing the Culturally and Linguistically Appropriate Services (CLAS) Standards to Life

Presenter: Mui Mui Hin-McCormick is a Licensed Marriage and Family Therapist who currently serves as Senior Special Projects Coordinator for the State of Connecticut Commission on Equity and Opportunity. Previously, she was Executive Director of the Asian Pacific American Affairs Commission. She has also been the Clinical Director for a community-based outpatient program. Ms. Hin-McCormick conducts a variety of diversity trainings for state agencies, nonprofits, and other providers on CLAS Standards, Working with Underserved Communities, Health Disparities, and Cultural Sensitivity. She is the recipient of the Connecticut Multicultural Health Partnership Community Leader Award.

Program Content: This workshop will provide background and a historical perspective on health equity and the CLAS Standards. It will also enable participants to assess their organization's readiness and capacity to reach and service diverse populations. Participants will have the opportunity to consider how the CLAS Standards relate to your organization's policy standards and statements; the training, supervision and performance evaluations of your staff members; and your engagement of and accountability to your communities. You will develop action steps to take upon returning to your organization.

Learning Objectives

- 1. Discuss the importance of health equity.
- 2. Describe the four focal areas addressed by the CLAS Standards and identify at least 10 of the 15 CLAS Standards.
- 3. Weigh your organization's capacity to reach diverse populations and assess readiness to implement the CLAS Standards.
- 4. Develop an action plan to bring these ideas back to your organization.
